7. Both parties agree that while implementing this MoU, they will not engage in unlawful discrimination on the grounds of race, gender, sexual orientation, age, religion, social class, national or ethnic origin or disability.

8. Amendments to this MoU may be made at any time after consultation and agreement between the two institutions. Any such amendment must be in writing and signed by both parties.

This MoU will remain in force for a period of 5 (five) years from the date it is fully executed. The MoU can also be suitably modified, as agreed to by both the parties, to reflect an increased scope, nature of engagement /activities including financial commitments, if any. Background

LK Consultants, a section 25 Company incorporated under the provision of The Companies Act, 1956 is conducting a "Internship Program" for enhancement of employability and workplace skills for deserving youth.

In this connection, **LK Consultants** intends to be associated and work closely with the College to conduct employability training and career counseling sessions for the final year college students. This will include activities through the year, till students are placed 10-12 months after their final year examinations. Features of the program are as follows:

1. Training or post training interaction sessions will be conducted in the college premises when LK consultants and the College deem fit.
2. There is no cost for students to attend the above mentioned training.

5. Students will be provided a certificate on successful completion of course with minimum attendance criteria of 90%.
6. Students will be further supported in job linkages and placements from the time of training completion till they are placed i.e. 6-10 months after their training is complete.
7. College is expected to support the successful training and placements of all students, should they take up this service with LK Consultants

For this purpose, LK Consultants requires support of the college in the following areas:

1. Facilitating discussions and engagement with the current third year degree students and graduates wherever feasible. This involves the following:
 - a. Assistance in student mobilization and batch scheduling with ongoing final year classes.
 - b. Support in allocating batches (of about 30-35 students approximately) per trainer for optimum utilization of resources and training effectiveness.
 - c. Provide assistance w.r.t. conducting career fests drive and continued student participation.
2. Infrastructure support for the following:
 - a. Availability of classroom to conduct post training engagement sessions and refresher sessions as and when required once the situation normalises.
 - b. Require college support to conduct a Parent engagement session in the college premises or via Online Platform.

Upon a request by LK Consultants for this support, the College has agreed to support and provide the appropriate assistance to LK Consultants, as mentioned below.

Based on the above, this MOU lays out immediate next steps to be taken by both parties.

LK Consultants agrees to -

1. Conduct Orientation sessions to make students aware about the program and register their interest.
2. Engage with students and form batches based on selection criteria for conducting the training program.
3. Conduct the Campus to Corporate Careers Program using online platforms.
4. Provide career counselling support to students enrolled in this program.
5. Facilitate further linkages with vocational training partners and employers for interested students.
6. Placement reports of students linked to job opportunities will be provided to the college once placement activities commence.

The College agrees to -

1. Facilitate the dissemination of information regarding the Internship Program to the final year or recent graduates and help LK Consultants to mobilise students.
2. Permit Online sessions to be conducted via Zoom or any application deemed appropriate.
3. Providing one contact point who could be approached for any support (student engagement) related to this program.

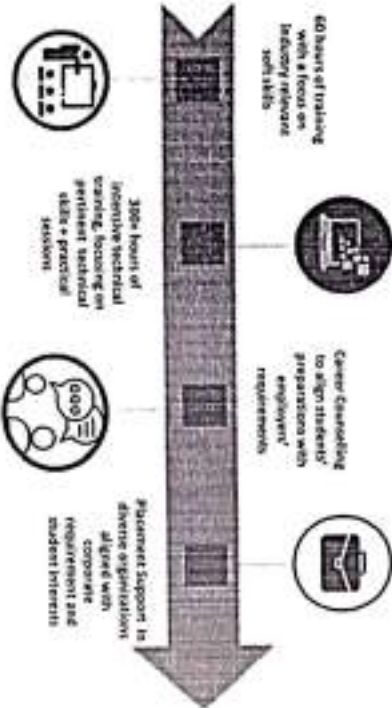

1 Net fees charged to the student for various courses is given below:

COURSE	Fees
Course Fees for MBA - CET	Rs. 8500/- Per student
Course fees for MBA - CAT	Rs. 20500 /- Per student
Course Fees for Bank PO	Rs. 7500/- Per student

- All above mentioned prices are excluding GST, [GST of 18% to be added to the above Fees Structure]. The Parties shall be at liberty to decide / alter / modify the Fees Structures, as per the mutual decision to be taken from time to time. Parties shall

decide the compliance of GST related processes, in writing in due course, not later than 15 days from the date of execution of these presents.

- ii. Sushiladevi Deshmukh College Airoli shall collect the Fees from Students, in a designated Online Account, to be opened only for this purpose and shall remit the Fees [to the extent of agreed Fees to be shared with Ideal Management] , Twice a week on Wednesday and Saturday].
2. The amount shall be paid to Sushiladevi Deshmukh College Airoli College directly by the student.
 3. Sushiladevi Deshmukh College Airoli College shall deduct 25% of the Net fees as its share and shall pay the remaining fees less TDS to Ideal Management towards the cost of delivering the coaching.
 4. Sushiladevi Deshmukh College Airoli College and Ideal Management shall be entitled to alter / modify the Fees Sharing Structures in writing, subject to change in circumstances, pattern and scope of work as described in this MOU, by mutual consent and from time to time.

05. CONFIDENTIALITY:

It is agreed that any information, details, documentation provided by Ideal Management is confidential information. The said information shall remain the sole property of the Ideal Management.

06. SINGLE POINT OF CONTACT:

Both Sushiladevi Deshmukh College Airoli College and Ideal Management shall nominate a single coordinator / more than one coordinator, who would be responsible for their respective organization. The Coordinator/s, shall ensure proper and effective communication between both parties and reporting to their own management for the day to day activities. Policy matters, however, shall be decided by the Governing Board of Sushiladevi Deshmukh College Airoli College and the Board of Directors of Ideal Management.

07. TERMINATION:

- i. This MoU is effective for the period as stated in clause 1 (Terms of the MoU) unless expressly terminated earlier in accordance with this section. To ensure that the course is conducted up to its successful completion irrespective of the batch size, Ideal Management agrees to indemnify Sushiladevi Deshmukh College Airoli College for any actual damages, claims arising out of its inability to successfully complete the course after collection of fees.
- ii. The termination of this MoU shall not however affect the obligations of the Parties incurred prior to the termination. Further, in the event the MoU is terminated by Ideal Management for whatever reason, Ideal Management agrees to complete the course duration for the students, who have already enrolled and started their classes. Ideal Management takes the responsibility for smooth running and completion of all the courses started by it.

08. FORCE MAJEURE

Neither Party shall be liable to other in respect of anything which, apart from this provision, may constitute breach of the Agreement arising by reason of force majeure, namely circumstances beyond the control of either party which shall include (but shall not be limited by) acts of God, civil or military authority, acts of public enemy, war, riots, civil disturbances, insurrections, accidents, explosion, fires, earthquakes, floods, transportation, embargoes, epidemics, acts of government, its agencies or officers. However, if as a consequence of such cause, performance by a party under this Agreement shall be prevented for a longer period than one month, then the other party shall have the right to termination under this condition with no liabilities and penalties.

09. CHANGES IN TERMS AND CONDITIONS:

The parties herewith agree to sign any other papers, documents in writing to effect any changes or variance of the above terms and conditions, mutually agreed and on such signing the terms and conditions shall become effective and part of this MoU with immediate effect.

10. ARBITRATION:

All disputes arising out of or in connection with the present agreement shall be settled through mutual negotiations, failing which the dispute shall be settled by the rules of the Rules of the Arbitration and Conciliation Act, 1996. The place for arbitration shall be Mumbai. The language of arbitration shall be English. The jurisdiction for any disputes with any third party shall be at Mumbai. All issues those may be referred for arbitration shall be resolved in maximum Three Months
